NOTIFICATION

No. A. 12018/29/80 -APT(B), the 20th September, 2000. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of Surveyor under Public Works Department and Public Health Engineering Department, Govt. of Mizoram namely:—

- 1. Short title (i) These Rules may be called the Mizoram Public Works Department and commencement. These Rules may be called the Mizoram Public Works Department and Public Health Engineering Department, (Group 'C' posts) Recruitment Rules, 2000.
 - (ii) They shall come into force on the date of their publication in the Official Gazette.
- 2. Application. These Rules shall apply to the post specified in column 1 of the Annexure-I hereto annexed.
- 3. Number of The number of the said post(s), their classification and the post, classification and the scale of pay attached thereto shall be as specified in Columns tion & Scale 2 to 4 of the Annexure-I aforesaid.

- 4. Method of The age limit, qualification and other matters relating to Rectt., age limit the said post shall be as specified in columns 5 to 14 of and other the Annexure-I aforesaid.

Provided that upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes or Scheduled Tribes and other special catgorites of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time.

5. Disquali- No person----

(a) Who has entered into or contracted a marriage with a person having a spouse living, or

who, having a spouse living, has entered into or contracted a 10) to the said post (s). to the said post (s).

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to other party to the marriage and that there are other grounds for doing so, exempt any such person from the operation of these rules.

Every Government servant recruited under these Rules shall undergo such training or pass such Departmental Examinations as may be prescribed from time to time.

ower to anster.

Notwithstanding anything contained in these rules, the Governor of Mizoram in public interest, shall have the right officer so any to transfer under these rules to any other post or position which is equivulent in rank or grade.

OJ TOWY lax.

Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to recorded in writing in consultation with the Departmental Promotion Committee/Mizoram Public Service Commission, as the case may be, through the Department of Personnel and Administrative Reforms, relax any of the provisions to these rules with respect to any class or category of persons.

Nothing in these Rules shall affect any reservations or other concessions required to be provided for the Scheduled Tribes/ Scheduled Castes and other categories of persons in accordance with the order issued by the Central Government or Government of Mizoram from time to time in this regards.
