If the documents are downloaded from the website, the demand draft may be included in the Technical Bid. Bidding documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs.2,500/-. 4. Bids must be accompanied by Bid Security of the amount specified for the work in the table above payable at **Aizawl** and drawn in favour **The Engineer-in-Chief, PHED, Govt. of Mizoram**. Bid Security will have to be in any one of the forms as specified in the Bidding documents and shall have to be valid for **45 days** beyond the validity of the bid..

Bids must be delivered to **The Engineer-in-Chief, PHED, Govt. of Mizoram** on or before **12:00 hours** on **5<sup>th</sup> September 2022** (date) and will be opened on the same day at **13:00 hrs**, in the presence of the bidders who wish to attend.
