**INSTRUCTIONS TO BIDDERS AND TERMS & CONDITIONS**

1. The terms 'Quotation', 'Tenders', 'Bid' have the same meaning in this Notice.
2. The quotation is invited for fixing the rate for supply, installation, testing and commissioning of the Demountable Water Steel Tank as mentioned in Appendix-I. The materials must be as per relevant specifications.
3. The Bidders shall submit the Bid in a sealed envelope addressed to 'The Engineer-in-Chief, PHED, PHED Building, Khatla, Aizawl -796001. Quotation no. and Date must also be clearly inscribed on the top of the envelope. The Department shall not, in any manner, be held responsible for postal delay or non-receipt of the Quotation sent by the Post.

4. The quotation received after the due date & time of opening shall not be accepted.
5. If the Office is closed on the stipulated date and time due to some unforeseen reason, quotation will be received up to and open in the next working day at the same place and time.
6. Quotation paper must be duly filled in all columns of the tender documents. No over writing will be allowed.
7. The Quoted rate should be for complete material FOR Mizoram inclusive of all taxes, Packing, Loading etc. complete in all respect and valid for a period of 1 (year). No escalation shall be entertained afterwards.
8. Bidders shall submit the following Documents along with the Bid:
