- 1) Tender document may be downloaded from the website <https://phed.mizoram.gov.in>
- 2) Manufacturers should produce valid BIS License as on date of NIT.
- 3) Quotation should be submitted in two sealed covers. The first cover shall contain the documents relating to eligibility criteria and the envelope should super scribe as TECHNICAL BID. The second sealed cover shall contain price bid and to be super scribed as PRICE BID. The technical bid will be opened first in presence of all participating bidders and if the technical bid qualifies, then only price bid will be opened. Otherwise the tender will be declared non-responsive/informal. The two sealed Covers are to be submitted in a large sealed cover to be superscripted Quotation No, Name of the Quotation and the date of opening.
- 4) The quantities shown are tentative and subject to change based on actual requirement.
- 5) The rates will be F.O.R Aizawl inclusive of all kinds of taxes, duties, insurance, transportation, loading, unloading etc. Bidders must quote the net Price both in words as well in figures. Any over writing/cutting etc render the tender invalid.
- 6) Total price should indicate the breakup of statutory payments (like GST, Inspection Fees, Transportation etc.) either in percentage or lump sum on the quoted price. Price quoted shall remain valid for the full financial year/365 days from the date of opening of quotation whichever is later.
- 7) All documents are to be submitted with quotation duly authenticated notarized.

**B. TECHNICAL SPECIFICATIONS :**

- 1) All pipes shall have as Cast or Stamped or legibly and indelibly painted on with the following appropriate mark:
  - a) Manufacturer name or Trade Mark
  - b) I.S no that is, IS 1239 (Part-I) : 2004
  - c) Class of pipes, that is M or H for Medium or Heavy class.
- 2) The different classes of Pipes shall be distinguish by 75mm colour bands, which shall be applied as follows before the tubes leave the manufacture's work:
  - 1) Medium class- Blue
  - 2) Heavy class- Red
- 3) The zinc coating on the pipes shall be in accordance with IS 4736. (360g per square meter).
- 4) Each pipe shall be tested for leak tightness as in – process test at manufacturer's work by Hydrostatic test. The Hydrostatic test shall be carried out at a Pressure of 5MPa & the same should be maintained for at least 3 second & shall not show any leakage in the pipe. The authentic Hydrostatic test certificate carried out must be produced at the time of submission of quotation and supply of materials. Quality control authority certificate may be attached.
- 5) The thickness, dimension, nominal mass and maximum permissible pressure of pipes should be maintained as per table 4, table 5 and table 6 of IS 1239 (Part-I) : 2004. Tolerance shall be permitted on the Pipes & Sockets as per IS 1239 (part-I) : 2004.
- 6) The Pipes should be socketed at one end and the other end should be protected with Plastic ring protector. Socket is to be fitted so tightly to pipe end that it should not fall down during handling or transit. The socket so fitted must be as per IS-1239 (part-I) 2004 is respect of OD and length.
- 7) All pipes shall be clearly finished & reasonably free from injurious defects. The ends shall be free from sharp edges burrs of the pipe. The pipes shall be reasonably straight.

C. ELIGIBILITY CRITERIA :

- 1) The Bidder should have an Average Annual Financial Turnover on Manufacture/Supply of G.I Pipes of atleast 40% of his quoted price during the immediate last 3 consecutive balance sheets (may range from six to eighteen months) duly audited by Chartered Accountant. Year In which no turnover is shown would also be considered for working out the average. Information may be furnished as per Appendix-IV, and may be included in technical Bid.
- 2) The Bidder should not have incurred any loss in more than two years during the last five consecutive balance sheets, duly certified and audited by the Chartered Accountant.
- 3) Bidders having the following experience of successfully completed works to any Government Department during the last 5 years are eligible to apply. The total quantity supplied during a financial year shall be considered as Completed Works:
