- 1) Tender paper will be issued only to bonafide manufacturer of G.I Pipes.
- 2) Manufacturers should produce valid BIS License as on date of NIT.
- Tender should be submitted in two sealed covers. The first cover shall contain the documents relating to eligibility criteria and the envelope should super scribe as TECHNICAL BID. The second sealed cover shall contain price bid and to be super scribed as PRICE BID. The technical bid will be opened first in presence of all participating tenderers and if the technical bid qualifies, then only price bid will be opened. Otherwise the tender will be declared non-responsive/informal. The two sealed Covers are to be submitted in a large sealed cover to be superscripted Tender No, Name of the tender and the date of opening.

- 4) The rates will be F.O.R Aizawl inclusive of all kinds of taxes, duties, insurance, loading, unloading etc. Tendered must quote the net Price both in words as well in figures. Any over writing/cutting etc render the tender invalid.
- 5) Price quoted shall remain valid for the full financial year/365 days from the date of approval.
- 6) All documents are to be submitted with Tender duly authenticated.
- 7) The tender received after the due date & time of opening shall not be accepted.
- 8) If the Office is closed on the stipulated date and time due to some unforeseen reason, tender will be received up to and open in the next working day at the same place and time.
- 9) Tender paper must be duly filled in all columns of the tender documents. No over writing will be allowed.
- 10) Manufacturers should have experience in manufacturing & supplying of G.I pipes and as per IS specification of diameter varying from 15mm of medium and heavy class and above for at least 5 years and the product should have given satisfactory performance for at least 5 years.
- 11) Manufacturers (Tenders) should produce valid PAN no. GST/Sales Tax clearance Certificate/Partnership deed.
- 12) Each & every page of NIT must be duly signed by the Tenderers with date.
- 13) Incomplete tenders will be summarily rejected.
- 14) All pipes shall have as Cast or Stamped or legibly and indelibly painted on with the following appropriate mark:
 - a) Manufacturer name or Trade Mark
 - b) I.S no that is, IS 1239 (part-I): 2004
 - c) Class of pipes, that is M or H for Medium or Heavy class.
- 15) The different classes of Pipes shall be distinguish by 75mm colour bands, which shall be applied as follows before the tubes leave the manufacture's work:
 - 1) Medium class- Blue
 - 2) Heavy class- Red

- 16) The zinc coating on the pipes shall be in accordance with IS 4736. (360g per square meter)
- 17) Each pipe shall be tested for leak tightness as in process test at manufacturer's work by Hydrostatic test. The Hydrostatic test shall be carried out at a Pressure of 5MPa & the same should be maintained for at least 3 second & shall not show any leakage in the pipe. The authentic Hydrostatic test certificate carried out must be produced at the time of supply. Quality control authority certificate may be attached.
- The thickness, dimension, nominal mass and maximum permissible pressure of pipes should be maintained as per table 4, table 5 and table 6 of IS 1239 (Part-I): 2004. Tolerance shall be permitted on the Pipes & Sockets as per IS 1239 (part-I): 2004.
- 19) The Pipes should be socketed at one end and the other end should be protected with Plastic ring protector. Socket is to be fitted so tightly to pipe end that it should not fall down during handling or transit. The socket so fitted must be as per IS-1239part-I) 2004 is respect of OD and length.
- 20) All pipes shall be clearly finished & reasonably free from injurious defects. The ends shall be free from sharp edges burrs of the pipe. The pipes shall be reasonably straight.
- 21) No conditional offer will be accepted.
- 22) The current Sales Tax/GST Clearance certificate or Latest copy of GST/sales Tax Return must be attached with the technical bid.
- 23) The tenderers can remain present himself or his authorize representative at the time of opening of tender.
- 24) All disputes are subject to the jurisdiction of the Courts at Aizawl.
- 25) The tender will be rejected straightaway without assigning any reason if the manufacturer involves in any criminal case, declared black listed by any Govt/Semi Govt. department/agencies etc.
